# **Student Meal Prices**

## **Breakfast**

First Meal FREE Second Meal - \$2.57

### Lunch

First Meal FREE Second Meal - \$4.31

## **Adult Meal Prices**

Breakfast - \$2.95 Lunch - \$4.95

### **Lunch Accounts**

### Students may,

• receive up to two meals maximum a day as long as there is money on student lunch accounts to purchase a second breakfast and or lunch meal. No a la cart purchases are available.

# Faculty/Staff may,

• receive a breakfast and or lunch meal as long as there is money on lunch accounts to purchase meals. No a la cart purchases are available.

# **Lunch Account Deposits**

Money may be applied to lunch accounts through the school's secretary via cash or check. Money will be deposited in lunch accounts for the day's meal service if turned into the school secretary prior to 9:00am. Debit and credit card lunch payments may be made by logging into <a href="mayerealtime.com">mymealtime.com</a> parent portal.
